RE: Police Officer Hiring List

It is recommended that your Commission approve the enclosed certified list of Police Officer candidates to be referred to the Police Chief for hiring consideration.

It should be noted that 606 3. of your PFC rules states the following:  
*"In accordance with these rules, a rank order for those final applicants will be established. This ranking will remain confidential and shall not be made known to either the Police or Fire Chief or any other person not on the PFC."* As such, the certified eligible list is referred in alphabetical order and the discussion on the final ranking of candidates should not include the Police Chief, members of the Police Department, or any other non-PFC member.

There were a total of 3 candidates that passed the oral examination and physical readiness test.

There was 1 candidate that did not pass the oral examination, but did pass the physical readiness test. There was 1 candidate that did not pass the oral examination, and had a medical exemption from taking the physical readiness test on Saturday.
