5 POLICE AND FIRE UPDATES

Chief Alexander states the department is working on a 2024 budget. Assistant Chief Kiel is working on a specializing training grant to include trauma informed training. Chief Alexander briefly talks about the Pathways to Hope program; the SPD program has been recognized throughout the state of WI due to its high success. This Summer has been busy on patrol as there have been an increase in complaints regarding pets off leash, ATV/UTV use, and fireworks.

Chief Vollbrecht states the total runs for the Fire Department are down about 100 runs compared to this time in 2021. The Fire Department has changed the way they respond to fire alarms and have been using the electric pickup truck to respond to certain calls; these measures have decreased the volume on the firetrucks. Chief Vollbrecht states the Fire Department have been completing their wellness and fitness testing which is done on an annual basis. Chief Vollbrecht briefly discussed recent and upcoming trainings in the department.
